PROPOSED CRITERIA FOR

PROF. B. G. PRASAD ORATION AWARD

1. The nominee for the Prof. B. G. Prasad Oration Award should be a **Life Member** of IAPSM for at least **past 15 years**.
2. The nominee for the Prof. B. G. Prasad Oration Award should have a minimum of **20 years** distinguished standing in the profession (after doctorate degree of MD in Community Medicine or Ph. D in Biostatistics) and **preferably** having a designation of Professor or above.
3. The nominee should have any kind of contribution in the upliftment of IAPSM UPUK State Chapter.
4. The Executive Committee of IAPSM UPUK State Chapter is **solely responsible** to take its decision on the **selection of nominee** as per the defined criteria.
5. The President/ Secretary of IAPSM UPUK State Chapter is/are responsible for collecting a brief Biodata and ofcourse the **CONSENT** of the nominee for the same.
6. More than **50%** of the members in the Executive Committee should agree on the proposed nominee for the same.
7. The decision of the Executive Committee of IAPSM UPUK State Chapter shall stand as its **final decision**.
