### **Proposed Criteria**

## Prof. Harivansh Chopra Best Oral Paper Award on Child

### Health

- 1. Essential Criteria Applicant must be a member of IAPSM at the time of paper submission.
- Subject matter for the award- The award is meant for papers on Implementational research or on Interventional research on Child Health.
- The research work must be approved by the Ethics Committee- Certificate must be enclosed
- 4. There is no age bar and any member of IAPSM UP UK Chapter can apply for the award.
- 5. The awardee must be Principal Investigator of the study
- Full manuscript (Published/ Un-published- Declaration by PI/Chief guide in case of PG that it is original work carried out by him/her) to be submitted before the due date.
- 7. Manuscript submitted for Award, may contain up to 4 tables and 2 figures, and should not exceed 2500 words (excluding the title page, abstract, references, tables, and figures). It should be prepared and presented in accordance with the guidelines for "IJCH/IJCM" research papers. Published papers also need to be submitted in the above format only, in no case the published paper should be sent as such
- The paper submitted must not have been presented earlier in any conference and has not been awarded a prize anywhere else till the time of the final presentation.
- 9. The papers must be one referring to original work done in India within the last five years.
- 10. The authors' names, workplaces, or places of employment shouldn't be revealed in the manuscript. Only Title Page, which is often the first page of the paper, and the Declaration Form that should be affixed to the submission/cover letter should contain these facts.
- 11. A panel of four to five judges—two of whom will be subject-matter experts—nominated by the Executive Committee will evaluate the papers submitted for the Award.
- 12. The award-winning paper will be presented at the Annual IAPSM-UPUKCON, with a time of 15 minutes (10 min Presentation & 5 min Q&A)
- 13. The judges reserve the right to forbid the presentation of an award paper if any technical issues with the paper are discovered at any point prior to the presentation.
- 14. The judgement of the panel of judges shall be final and binding on all parties.
- 15. The Principal investigator (the main author) will get the Medal/cash prize and a certificate of merit in the event while other co-authors will receive a merit certificate.
- 16. The principal investigator must have carried out the original and direct research that is the subject of the paper for award. The Executive Committee will take strict action, which may include withdrawing such an award with public notice if it is later discovered that the task was not completed by the person in question.

## **Proposed Criteria**

# & Child Health for Post Graduate Student

- Essential Criteria PG student in Community Medicine from any of the medical colleges in the state of UP and Uttarakhand. Applicant must be a member of IAPSM.
- 2. Subject matter for the above award- The award is meant for original research studies on maternal & child Health.
- 3. The research work must be approved by the Ethics Committee- Certificate must be attached
- 4. Declaration by HOD/Chief guide that the PG has completed the original work under his/her guidance to be submitted before the due date.
- 5. Full manuscript with Rationale/Introduction, objective, methodology, results & discussion not exceeding 2500 words (excluding the title page, abstract, references, tables, and figures). in accordance with the guidelines for "IJCH/IJCM" research papers must be submitted before due date
- 6. The study should not have been presented earlier in any conference Declaration by applicant
- 7. The poster presented will not be taken into consideration if they have already been published in scholarly journals.
- The applicants names, workplaces, or places of employment shouldn't be revealed in the manuscript submitted.
- A panel of four to five judges—two of whom will be subject-matter experts—nominated by the Executive Committee will evaluate the manuscript submitted for the Award.
- 10. The award-winning poster will have to be presented as a poster in person at the Annual IAPSM-UPUKCON in the session on Maternal & Child Health
- 11. The judges reserve the right to forbid the presentation of an award poster if any technical issues with the study are discovered at any point prior to the presentation.
- 12. Judgement of the panel of judges shall be final and binding on all parties.
- 13. The Principal investigator (the main author) will get the gold medal/cash prize and a certificate of merit in the event while other co-authors will receive a merit certificate.
- 14. The manuscript submitted for the award must be original research of the applicant on Maternal & Child Health. The Executive Committee will take strict action, which may include withdrawing such an award with public notice if it is later discovered that the task was not completed by the person in question.
